We reserve the right, based on availability, to determine the possibility of make-up dates, or you may donate your share for that week to a friend or to be dispersed among members.

**Touch the Earth Farm CSA Agrees to:**

Touch the Earth Farm agrees to provide weekly for twenty weeks a variety of fresh-picked, seasonally-available produce. Variety and quantity of each kind of produce is at the discretion of TTE based on harvest availability, which includes certain risks of drought and predation that TTE will do our best to minimize or mitigate.

We pledge our best effort to ensure crop success using sustainable methods, to limit membership to manageable numbers ensuring quantity and quality for all members, to maintain open communication with our members, and to continue learning and growing in sustainable agriculture and in partnership with our member community.

We commit ourselves to using recyclable and reusable materials and eliminating the use of plastics as part of our larger commitment to our community and the planet.
